The CDEX application provides an eCommerce interface for Check Stub Data Exchange (CDEX).

Oil and gas purchasers, operators and/or interest owners can upload and/or download revenue check stub detail to/from data providers who support the CDEX system.

The CDEX application's download capabilities eliminate the need for keyboard data entry of revenue check stub detail. The CDEX application requires a subscription to OILDEX, the CDEX data provider.

## Overview

The Integra Check Stub Data Exchange (CDEX) application provides an eCommerce interface alternative to manual keyboard data entry of Revenue Check Stub Detail items.

The Integra CDEX application can work with multiple check stub data providers and supports the Petroleum Industry Data Exchange (PIDX) Check Stub Data Exchange (CDEX) standard. If you have Integra Revenue Distribution installed, the Integra CDEX Interface also provides the ability to upload distributed revenue check stub information to your royalty and working interest owners who have requested their data be electronically transmitted to them. The upload or transfer of CDEX data can be accomplished via one of several data providers or via direct eCommerce trading partner to trading partner exchange. Data can be exchanged via modem connections, the Internet, email message transfer or direct fixed media.

The primary CDEX data provider, OILDEX, offers data warehouse and clearinghouse services wherein the oil & gas purchasers or operators (senders) can transmit the revenue check stub information for all subscribing owners to a central computer, and the individual oil & gas interest owners (receivers) can subsequently download their revenue information. The tremendous value of such a service lies in the fact that, although the revenue checks and stubs come in the mail, the detail check stub line item data is already "downloaded and waiting" and only needs edit verification.

The system provides for the translation of CDEX codes into valid Integra system codes. Once the CDEX formatted revenue data has been downloaded, the data is imported into a central capture file. From this central capture file, each company is able to extract and transfer its check stub data into the Revenue Entry system for processing.
